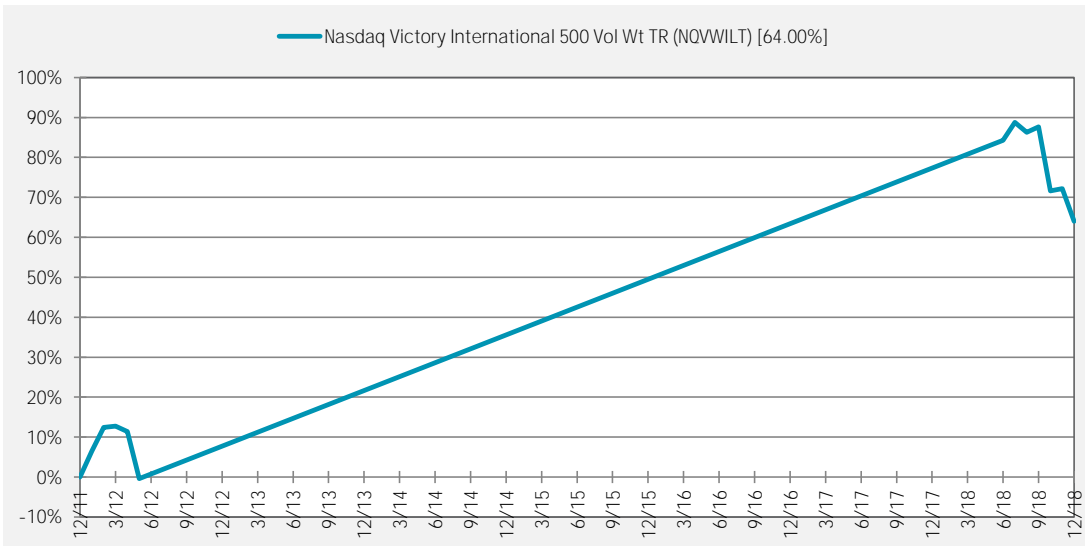


# Nasdaq Victory International 500 Vol Wt TR

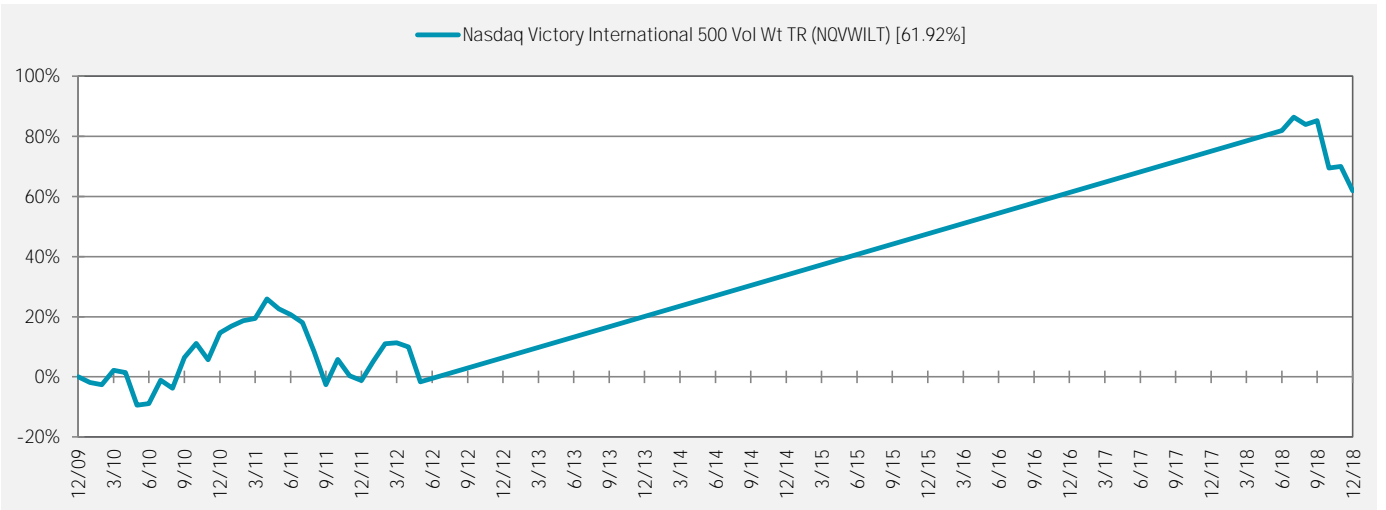

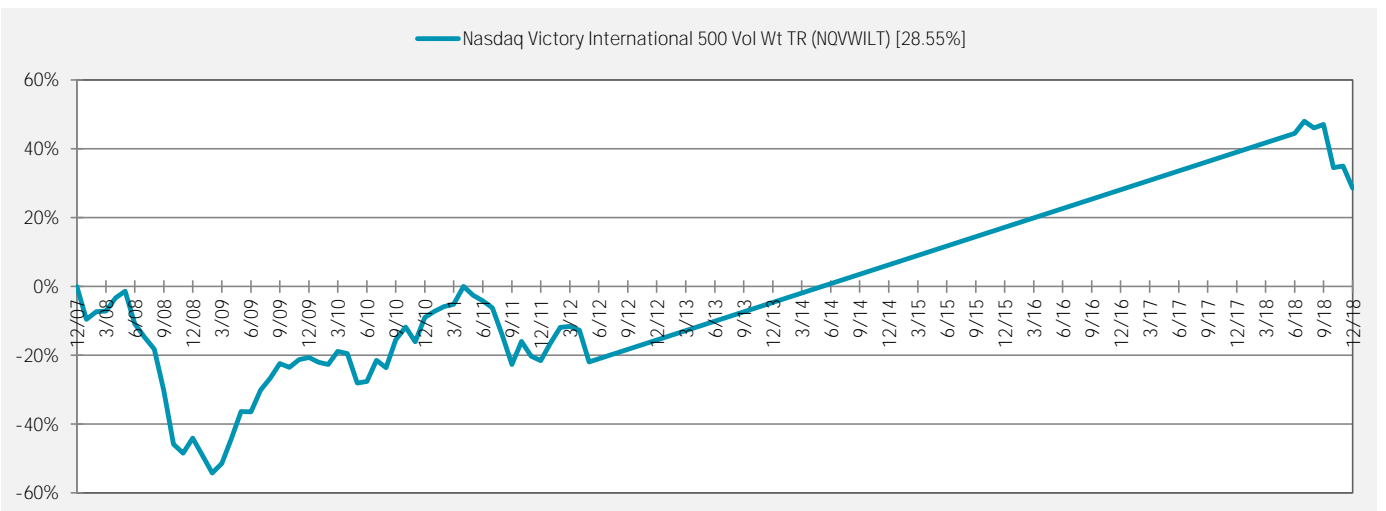

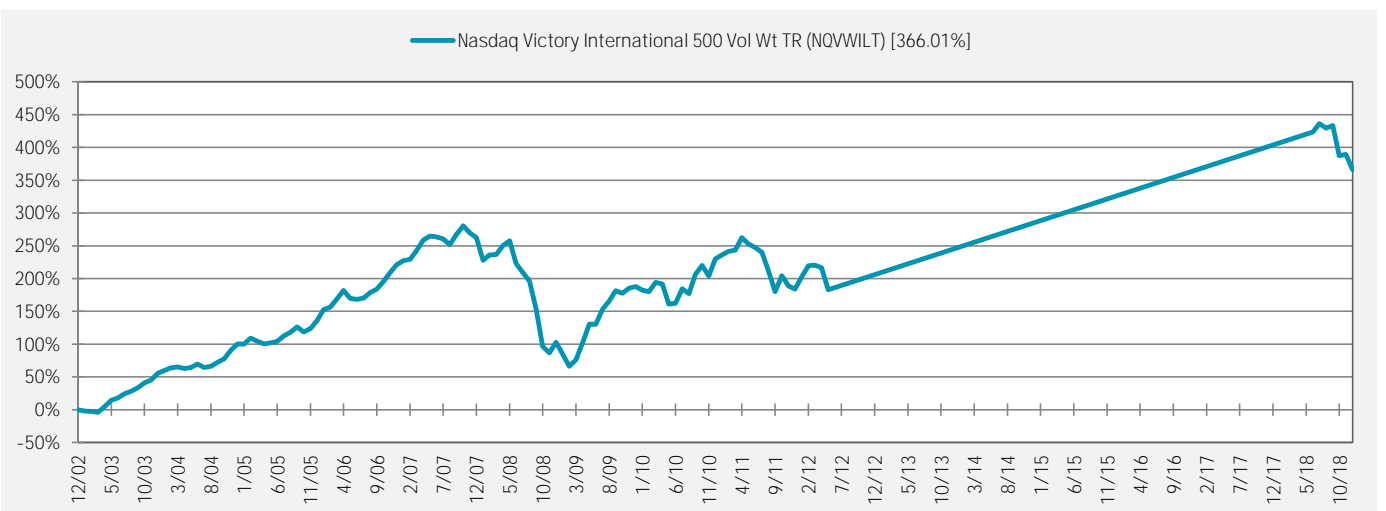
### 3-YEAR PERFORMANCE
